- The pool party fee will continue to be \$40. We cannot schedule parties on holiday weekends. We encourage that you schedule parties after 4:00 pm. Remember, the pool is NOT closed to other residents during your party.
- The pool will be opening on Saturday, May 17. Hours will be from 9AM to 9PM. If you need a key fob, please contact Chris Mavroudis.
- Per David, we have signed a new contract with PMI for 2025-2027. They have made some much needed repairs and performed winter maintenance.

Rules and By Laws – David Baldwin

- No changes proposed in the By Laws
- We had an issue with a fire burning out of control in a neighbor's backyard. Please be sure to check the Gwinnett County website before you burn. Most days are designated "no-burn" days due to excessive dryness and wind. We strongly discourage burning lawns to remove thatch. It can be risky, potentially causing damage to the lawn and posing fire hazards.

Capital Projects – David Baldwin/Cynthia Sullivan

- We will need to replace the pool covering before the fall. Cost will be approximately \$10,000
- We need to put a new coating on the pool deck. Cost will be approximately \$4,000
- A big thank you to Cynthia Sullivan for presenting plans for major improvements in the playground area. She is extremely qualified to make this project happen. There seemed to be unanimous approval from the meeting attendees to move forward

with this plan. It could take several years. Please see attachment for the scope of work.
